

## Strategy Overview

The Cambria Trinity ETF (BATS: TRTY) seeks to track the performance, before fees and expenses, of the Cambria Trinity Index. The index employs a balanced, systematic approach to asset allocation, focusing on diversification, value investing, and trend following. The Cambria Trinity ETF uses a buy and hold strategy that aims to produce a balanced, low-turnover portfolio of investable assets.

## Fund Description

The Cambria Trinity ETF targets investing in ETFs that provide exposure to global stocks, bonds, and real assets. Additionally, the strategy incorporates tilts toward value and momentum investments, and trend following. TRTY has no management fee, and a 0.66% expense ratio (pass-through from underlying ETFs), allowing the cost-conscious investor to hold a diversified, low-cost global asset allocation portfolio with a moderate risk profile.
